

BRANCH NEWS

In December, the branch board members met with Durl Kruse, a representative from the C-U Citizens for Peace & Justice (CUCPJ) to learn about the CUCPJ statement to halt police militarization in our community. CUCPJ had asked that our branch join other local organizations to support the statement. At the conclusion of the meeting with Mr. Kruse, the request and supporting information was sent to board members for their input. In addition, we were in communication with the Grassroots Advocacy Coordinator at AAUW. Based on the information we received from national, the Branch made the decision to not sign in support of the CUCPJ statement. We appreciated the opportunity to learn more about this important issue, as well as learning about the work of AAUW with local advocacy. In summary, we learned that AAUW uses the member-adopted Public Policy Program and policy resolutions as their guide to examine federal policies and programs prior to taking any position. Given that the CUCPJ statement referenced a specific federal program (1033), which AAUW had not yet examined, the Branch decided to not take a position at this time.

Important to note – our process of considering the request enabled us to engage with one another and with community members around important issues of safety and racial justice – activities encouraged by AAUW. Thank you to everyone for their careful consideration of this question.

Upcoming Selections:

January 27 - Mountains Beyond Mountains: The Quest of Dr. Paul Farmer, A Man Who Would Cure the World (2003) by Tracy Kidder.

Doctor, Harvard professor, renowned infectious-disease specialist, anthropologist, and recipient of a MacArthur "genius" grant, Farmer found his life's calling: to diagnose and cure infectious diseases and bring the lifesaving tools of modern medicine to those who need them most. The story takes us from Harvard to Haiti, Peru, Cuba, and Russia as Farmer changes minds and practices through his dedication to the philosophy that "the only real nation is humanity"—a philosophy that is embodied in the public charity he founded, Partners in Health. Jim Yong Kim, current President of the World Bank, is also featured in the story for his early work with Partners in Health.

February 24 - The Bill of the Century: The Epic Battle for the Civil Rights Act by Clay Risen (2014) - or - An Idea Whose Time Has Come: Two Presidents, Two Parties, and the Battle for the Civil Rights Act of 1964 by Todd S. Purdum (2014).

Passage of The Civil Rights Act of 1964 was a broad, epic struggle, a tale of unceasing grassroots activism, ringing speeches, backroom deal-making, and finally, hand-to-hand legislative combat. The Kennedy brothers, Lyndon Johnson, Martin Luther King Jr., Hubert Humphrey and Everett Dirksen, plus many other legislators whose roles are less well known, are the featured players in these highly detailed reports of the process that vividly supports the adage that we don't really want to know how either laws, or sausage, are made. Both books utilize the same historical resources so you can read either book to get the inside story.



March 24 - The Girls of Atomic City: The Untold Story of the Women Who Helped Win World War II by Denise Kiernan (2013).

At the height of World War II, the US government secretly created a city in Tennessee for enriching uranium to fuel the new atom bomb that was being assembled at Los Alamos, NM. Called Oak Ridge, the city housed more than 75,000 workers at its peak, many of them young women. Workers were told that their work would speed the end of the war, but were never told the true nature of their tasks until the war was officially over. Secrecy was strictly enforced and workers were not allowed to discuss their work or to even speculate about its purpose, either with fellow workers or outsiders. The author interviewed former Oak Ridge workers, now in their 80s and 90s, who described their lives and work during this historic time.
