LOCAL SCHOLARSHIPS

The committee met and reviewed the applications for the scholarships for both Parkland College and the University of Illinois at Urbana-Champaign, and identified candidates to receive the offer of scholarships for the 2016-2017 academic year. More information about the recipients will be included in the fall newsletter.

Ida King Stevens Scholarship - Our AAUW branch awards a \$1,000 Ida King Stevens scholarship to a female who is enrolled or accepted to the University of Illinois who has experienced an interruption of at least two years in formal education and has an minimum cumulative grade point average of at least 2.5/4.0.

Parkland Scholarships: Southwood-Van Es; Amy Kummerow; Phyllis Cline – Our branch awards three \$1,000 scholarships to females who are residents of the Parkland District or state of Illinois who have experienced an interruption of at least two years in their formal education, and are enrolled or have been accepted for full or part-time study at Parkland with a cumulative grade point average of at least 2.0/40.
