**Local Scholarships**—We pay \$1000 each for three Parkland scholarships. Donations are not tax deductible if made payable to the branch because branches are 501(c)(4) organizations. To receive a tax deduction for a local scholarship donation, write a separate check made payable to Parkland College Foundation and in the Memo section specify the scholarship you are supporting—Southwood-van Es, Amy Kummerow, or Phyllis Cline. You may mail your check directly to Parkland College Foundation or include the Parkland check with your dues renewal form.

**AAUW's National College Conference for Women Student Leaders (NCCWSL)**. - Donations to the NCCWSL scholarship are not tax-deductible. Yearly, we pay \$600 for one scholarship to allow a young woman to attend the conference. Make the check out to C-U AAUW for that fund.

**National office's Fellowships/Grants, and Legal Advocacy Fund**, are tax deductible. You may donate online or include these donations in your dues check. The branch will then submit your donations and you will receive an official acknowledgment letter from the national office.
